

WiredWest

How many of you have kitchens that were just fine with two outlets 20 years ago, but now you have six small appliances and are already eyeing another one for Christmas and trying to figure out how to get more outlets? How many of you had one phone in the living room 20 years ago, and now have portable phones everywhere but the bathroom? How many of you did not own a cell phone just ten years ago, and now there are three people in your house with smart phones, as well as at least one tablet, a reading device, and a computer or two? This is the direction in which we are all moving. None of us will go back to less technology. Even those of us who say we will never need that nonsense may soon find that if we want to stay in our homes longer, we will need to be connected via WiFi to our doctors. We already know that our homes are much harder to sell without it, that our children can't come back here to live without it, and that our home-based businesses simply struggle to survive without it.

WiredWest and MBI are at a crucial moment in this massive regional project to get fiber optic to our homes, by far the best option, and one that will last for decades. Any other options, broadband, DSL, etc., simply can't keep pace with our growing needs, and will need hugely expensive upgrades every few years. You can be sure those expenses will be passed on to us as consumers, while the WiredWest option will one day bring our towns financial returns. The good news is that we are at a point where concrete steps must be taken, by us and by our towns. We are going to be asked soon to make a refundable deposit to be applied to installation charges when the network has been built. This will enter into all the planning for the network, and may well affect how soon we get it, based on each town's response. We, and our towns, will need to make a real commitment in securing the future for ourselves, and for Leyden.

Much more information will be coming soon. In the meantime, Al Woodhull and I are looking for some help from some more technologically savvy, or even just technologically desperate, Leydenites to help us move forward. We are going to need some real supporters of this project who might be willing to meet to discuss the next steps. Of Tea and Thanksgiving

I finally discovered what tea is all about. I know, I know, it took me long enough. I have always been someone who takes life on at 100 miles an hour with my hair on fire and tea always kind of ticked me off. It is too hot to drink and has no flavor when you first pour it and too cold to drink and is too strong if you let it sit. I'm not very patient. That's true of society in general. We love instant gratification. We expect our internet to run at high speeds, our microwaves to cook our popcorn speedily and our meals to be delivered quickly at restaurants. Chili's Bar and Grille even has a new electronic screen device at the table called a Ziosk where you can push a button to order your dessert halfway through your meal to avoid any of that pesky waiting around. I think that is really cool, but unfortunately, it feeds our desire as a society to move onto the next thing.

What I discovered was this: a cup of tea is bliss. It is time sitting still. It is a time of sitting still long enough that my kitten is delighted to find a place to rest on my lap. She reminds me that this is very unusual in the course of a busy week of jumping up to answer the phone or run to the next meeting. Sitting with a cup of tea is a radical countercultural slowing down in a world which speeds along. It is time valuing talking with your friends or loved one or pouring over a wonderful book or today's news. It's time savoring the moment, savoring the flavor of the tea and even savoring and opportunity to be alone with your thoughts, perhaps even prayers.

I think we all need some of that serenity this time of year especially. It tends to be a time of year when a lot of organizations plan special meetings and events and it can leave us quite breathless as the holidays approach with even more opportunities to be too busy shopping and cooking and wrapping and writing cards and entertaining family and friends.

Of the Ten Commandments, the fourth is, "Remember the Sabbath." For some people, Sunday is their Sabbath day, a day when they go to church. Worship is an important part of that day, but not the only part. Because I'm a pastor and work on Sunday, my Sabbath day is Tuesday. It's a day when I praise God by appreciating all that has been created. It's a time that I set aside to do nothing so that I can appreciate everything. Author Eugene Peterson reminds us that it is a time "to set aside our anxious attempts to make ourselves useful, to set aside our tense restlessness, to set aside our media-satiated boredom. Sabbath is the time to receive silence and let it deepen into gratitude, to receive quiet."

One of my favorite Bible passages is from Isaiah 58:13-14 (MSG). It says, "Treat the Sabbath as a day of joy, God's holy day as a celebration. If you honor it by refusing 'business as usual,' making money, running here and there—then you'll be free to enjoy God!"

That is what I learned about drinking tea. It is a time to receive silence and quiet and allow me to deepen my gratitude for the beauty of nature and family and community. It is a time of Sabbath, refusing business as usual and enjoying God's creation. In this season of gratitude and thanksgiving, I pray you will find a way to embrace that silence and joy in the midst of the bustle of busy-ness.

Let's put the tea in Thanksgiving, allowing time for silence and letting it deepen into gratitude! *Reverend Cheryl Meachen*

Landscapers and the Massachusetts Wetlands Protection Act



Wetlands Protection Program

The Wetlands Protection Act [Massachusetts General Laws (MGL) Chapter 131, Section 40] protects wetlands as well as other resource areas and the public interests they serve, including flood control, prevention of pollution and storm damage, and protection of public and private water supplies, groundwater supply, fisheries, land containing shellfish, and wildlife habitat. These public interests are protected by requiring a careful review of proposed work that may alter wetlands. The law protects these wetlands and other resource areas, such as land subject to flooding (100-year floodplains), the riverfront area (added by the Rivers Protection Act), and land under water bodies and waterways.

At the local level, the city or town conservation commission administers the Wetlands Protection Act. The commission is a volunteer board of three to seven members appointed by the selectmen or city council. On the state level, the Department of Environmental Protection (MassDEP) oversees administration of the law. MassDEP develops regulations and policies, and provides technical training to commissions. MassDEP also hears appeals of decisions made by commissions.

What are these protected resource areas?

Bank – any Creek, River, Stream, Pond and/or Lake.

Bordering Vegetated Wetlands – Wet Meadows, Marshes, Swamps and/or Bogs that border rivers and streams, ponds and lakes.

Land Under Water Bodies and Waterways – Under any Creek, River, Stream, Pond or Lake.

Land Subject to Flooding – Bordering and Isolated Areas.

Riverfront Area - the area of land between a river's mean annual high water line and a parallel line measured horizontally typically 200 feet out.

Both Bank and Bordering Vegetated Wetlands have a 100 foot regulated area known as the buffer zone.

The conservation commission ensures that proposed activities will not alter resource areas and the public interests they provide by reviewing projects on a case-by-case basis according to regulations [310 Code of Massachusetts Regulations (CMR) 10.00]. The regulations describe how each type of resource area provides one or more of the public interests. The regulations also spell out the type and extent of work allowed in resource areas. Proposed work must meet these standards. This information helps landowners and developers plan their work and helps commissions apply the law to specific projects.

The law regulates many types of work in resource areas, including vegetation removal, regrading, and construction of houses, additions, decks, driveways, and commercial or industrial buildings. If you want to work in a wetland resource area or within 100 feet of a wetland (an area called the buffer zone), contact the conservation commission before you start work.

If you are unsure whether your proposed work site is in a resource area or whether the work will alter a resource area, you can apply for a Request for Determination of Applicability. If the conservation commission determines that the work will alter a resource area, you must file an application, called a Notice of Intent (NOI), and pay an application fee.

Certain activities conducted by landscapers are considered an exempt activity if conducted within the Riverfront Area or with the buffer zone to Bank and the wetlands. These activities are:

1. Unpaved pedestrian walkways for private use;

2. Fencing, provided it will not constitute a barrier to wildlife movement; stonewalls; stacks of cordwood;

3. Vista pruning, provided the activity is located more than 50 feet from the mean annual high water line within a riverfront area or from bordering vegetated wetland, whichever is farther;

4. Plantings of native species of trees, shrubs, or groundcover, but excluding turf lawns;

5. The conversion of lawn to uses accessory to residential structures such as decks, sheds, patios, and pools, provided the activity is located more than 50 feet from the river's edge within the riverfront area or from bordering vegetated wetland, whichever is farther, and erosion and sedimentation controls are implemented during construction

6. The conversion of impervious surfaces to vegetated surfaces, provided erosion and sedimentation controls are implemented during construction; and 7. Activities that are temporary in nature, have negligible impacts, and are necessary for planning and design purposes.

Other activities are not regulated:

- 1. Mowing of existing lawns; and
- 2. Pruning of landscaped areas.

Local Wetlands Bylaws

Over 100 Massachusetts communities have local wetlands protection bylaws in addition to the state and federal laws described here. Contact the conservation commission at your city or town hall for more information about local bylaws.

If you are not sure whether or not the work you are doing is an exempt activity, you should contact your local conservation commission

Please **DO** include the following items in your paper recycling mix:

- \checkmark corrugated cardboard boxes
- ✓ paperboard gift boxes



TIP: Keep a recycle bin or paper bag near gift wrapping and unwrapping.

- \checkmark greeting cards (except those with foil, metallic inks, or glitter)
- ✓ wrapping paper, gift bags, tissue wrap (except those with foil, metallic inks, or glitter)
- ✓ paper shopping bags (any type of handle is okay)
- \checkmark catalogs and calendars

Please **<u>DO NOT</u>** include the following items in your recycling mix:

- ribbons, bows, and tinsel (reusable from year to year)
- > packing peanuts and Styrofoam (accepted for reuse at Greenfield UPS Store)
- > holiday lights (WtE scrap metal recycler in Greenfield pays for light strings)
- > plastic bags (clean, dry plastic bags marked #2 or #4 recyclable at some retailers)
- blister packaging (formed plastic package used to hold toys and electronics)
- > photographs
