**ARTICLE 8-**

To see if the Town will vote to raise and appropriate, or transfer from available funds, the sum of \$1,500.00 to the Land Acquisition Fund, to be administered by the Conservation Commission, or take any vote or votes in relation thereto.

**ARTICLE 9-**

To see if the Town will vote to raise and appropriate \$62,911.00 or transfer from available funds, the sum of \$62,911.00 for a one time operational subsidy to the Broadband Enterprise, or take any vote or votes in relation thereto.

Bill Glabach moved to transfer \$62,911.00 for a one time operational subsidy to the Broadband Enterprise. Lance Seconded. Unanimously approved.

**ARTICLE 10-**

To see if the Town will appropriate \$118,611.00 for Broadband Enterprise Fund Operations in FY2020 with \$55,700.00 to be funded by user fees and \$62,911.00 from taxation from Article 9 of the ATM warrant, or take any vote or votes in relation thereto.

Bill Glabach moved to let Bob Ryan see if the town will appropriate \$118,611.00 for Broadband Enterprise Operations FY2020 with \$55,700.00 to be funded by user fees and \$62,911.00 from taxation from Article 9 of the ATM warrant. Lance Fritz seconded. Unanimously Approved.

**ARTICLE 11-**

To see if the Town will vote to accept any sum of money that may be granted by the Quintus Allen Trust Fund, and to appropriate such funds for equipment, activities and supplies for the benefit of Leyden children, or take any vote or votes in relation thereto.

Quintus Allen was an original trustee of the Greenfield Savings Bank. Upon his death in 1884, he established a trust fund to be used for education-related expenses in Colrain, Gill, Leyden, and Shelburne. The interest earned by the Trust is distributed to those towns each year. The Town received \$2,640.96 from the Trust this year.

Bill Glabach moved to accept any sum of money that may be granted by the Quintus Allen Trust. Bob Ryan Seconded. Unanimously Approved.

## **ARTICLE 12-**

To see if the Town will vote to authorize the Board of Selectmen to petition the General Court for special legislation to allow Gilda Galvis, Town of Leyden Police Officer, notwithstanding the provisions of any general or special law to the contrary, to serve in such position until the age of 70, or until the date of her retirement or non-reappointment, whichever occurs first; provided, however that no deductions from the regular compensation of Gilda Galvis shall be made under chapter 32 of the General Laws subsequent to her reaching the age of 65 in connection with her service to the Town for retirement or pension purposes; provided, however, that the General Court may make clerical and editorial changes of form only to the bill unless the Board of Selectmen approves amendments to the bill prior to enactment by the General Court, and to authorize the Board of Selectmen to approve such amendments which shall be within the scope of the general public objectives of the petition, or take any vote or votes in relation thereto.

Bill Glabach Moved to authorize the board of selectmen to petition the General Court for special legislation to allow Gilda Galvis, Town of Leyden Police Officer, notwithstanding the provisions of any general or special law to the contrary, to serve in such position until the age of 70, or until the date of her retirement or non-reappointment, whichever occurs first. ## **ARTICLE 13-**

To see if the town will vote to accept the provisions of M.G.L. c, 64G, section 3A, and impose a local excise tax upon the transfer of occupancy of any room or rooms in a bed and breakfast establishment, hotel, lodging house, short term rental, or motel located within the Town at a rate of 6% (choice of percent up to 6%), said excise tax to take effect on the first day of the calendar quarter commencing at least thirty days after such vote of the Town Meeting, or take any action relative thereto.

To see if the Town will vote to accept and expend any sum of money that may be available under the provisions of Chapter 90 of the Massachusetts General Laws and authorize the Selectboard to enter into a contract with the Massachusetts Highway Department, and to authorize the Treasurer with the approval of the Selectboard, to borrow in anticipation of 100% reimbursement of said amount.

Bill Glabach moved to vote to accept and expend any sum of money that may be available under provisions. Bob Hardesty Seconded. Unanimously Approved.

## **ARTICLE 19-**

### **RESOLUTION IN SUPPORT OF CHANGING THE STATE FLAG & SEAL OF MASSACHUSETTS**

**Whereas** the history of the State of Massachusetts is replete with instances of conflict between the European Colonists and the Native Nations of the region, who first extended the hand of friendship to the Colonists on their shores in 1620, and helped them to survive starvation during the settlers' first winter on their land;

Whereas members of the Native Nation for whom the State of Massachusetts is named were ambushed and killed by Myles Standish, first commander of the Plymouth Colony, in April of 1623, barely two years after the Pilgrims arrived on their shores;

Whereas the naked Colonial broadsword brandished above the head of the Native man on the Massachusetts State Flag and Seal is modeled over Myles Standish's own broadsword, borrowed from the Pilgrim Hall in Plymouth by the illustrator Edmund Garrett in 1884;

Whereas the belt binding the Native's cloak on the Flag and Seal is modeled after a belt worn by Metacomet, known to the English as King Philip, who was among the Wampanoag leaders who resorted to a mutually destructive war in 1675-76 in defense of Native lands against Euro-Colonial encroachment;

Whereas the proportion of the body of the Native man in the flag and Seal were taken from a Native skeleton kept in Winthrop, the bow modeled after a bow taken from a Native man shot and killed by a colonist in Sudbury in 1665, and his features taken from a photograph of an Ojibwe chief from Great Falls, Montana, considered by the illustrator to be a "fine specimen of an Indian," though not from Massachusetts;

Whereas the history of relations between Massachusetts since Colonial times and the Nations who continue to live within its borders includes the forced internment of thousands of so-called "praying Indians" on Deer Island, in Boston Harbor, where they died by the hundreds of exposure in 1675, their subsequent enslavement in Boston, Bermuda, and the Caribbean Islands, the offering of 40 pounds sterling as bounty for the scalps of Native men women and children in Massachusetts beginning in 1686, increased to 100 pounds sterling for the scalps of Native adult males by 1722, half that amount for Native women and children;

Whereas Native Nations within the boundaries of Massachusetts were kept in a state of serfdom, and their members legally considered incompetent wards of the state until the nonviolent action of the so-called Mashpee Rebellion of 1833 led to the granting of Native self rule by the Massachusetts legislature in 1834, as if the sovereign right of Native self-government was the Massachusetts legislature's to confer;

Whereas Native Americans were legally prohibited from even stepping foot into Boston from 1675 until 2004, when that law was finally repealed

Whereas the 400<sup>th</sup> anniversary of the landing of the Euro-Colonists at Plymouth Plantation, which gave the rise to the long chain of genocidal wars and deliberate policies of cultural destruction against Native Nations of this continent, is approaching in the year 2020, affording every citizen of the Commonwealth a chance to reflect upon this history and come to a new awareness of a better relationship between the descendants of the Euro-Colonial immigrants and the Native Nations of the Commonwealth;

And whereas Native Americans have long suffered the many abuses of racism, the appropriation of their symbols for public schools and sports teams, the diminution and pollution of the ancestral lands and the encroachment of their cultural lifeways;

Whereas the land area now known as the Town of Leyden shares a rich Native history with modern tribal Nations such as the Abenaki, who frequented this area for thousands of years before the first colonial settlers arrived in 1737;

Now, therefore, **BE IT RESOLVED** that the Town of Leyden hereby adopts this resolution in support of H.2776 and S.1877, a **“Resolve Providing for the creation of a Special Commission relative to the Seal and Motto of the Commonwealth,”** and requests that Representative Paul Mark and Senator Jo Comerford continue their strong advocacy and support for the aforementioned Resolve (H.2776 and S.1877) in the General Court, and that the Joint Committee on the State Administration and Regulatory Oversight, and after holding a public hearing on the Resolve report it out favorably, and if the legislation shall pass that the governor shall sign it and work with members of the General court to ensure its enactment.


Wally Motioned to support of the changing of the State Flag and Seal, Warren Facey Seconded.
