Our MBI Grant Proposal was discussed. We are likely going to use the money to check/review the legality of our town authorization and debt exclusion votes as well as to check that our Municipal Lighting Plant was formed properly and that its organizational structure is legally correct.

Sheila reported about the Wired West meeting in New Ashford earlier in June.

Some discussion about the MBI documents to be filled out and fees associated with our upcoming pole study.

The committee discussed adoption of Active Internet versus GPON for our network in Leyden.

Wired West will be meeting in Leyden on July 23rd and all are invited.

The committee has a strong feeling that Leyden needs to enable every house to connect to broadband if they wish.

Al wants to listen to a proposal from Matrix Services. We will wait to meet with them until after our 21 day period is over with MBI.
