Jeff called the meeting to order at 6:00 pm. Selectboard signed FY 22 warrants.

Daniel Crovo from Gill Engineering recommends the award be given to the lowest bidder Clayton Davenport Trucking for \$492,360.00. He reviewed all bids and construction costs. ## Powers Equipment proposal for assessment plan
