To a Constable in the Town of Leyden, in the County of Franklin, GREETINGS:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said Town, qualified to vote in elections and in Town affairs, to meet at 7:00 in the evening on Monday, June 17, 2019 in the LEYDEN TOWN HALL on West Leyden Road, Leyden, MA, then and there to act upon the following articles:

ARTICLE 1-

To see if the Town will vote to raise and appropriate or transfer from available funds the sum of \$794,653.00 to fund Leyden's portion of the PVRSD budget for FY 2020, or take any vote or votes in relation thereto.

ARTICLE 2-

To see if the Town will vote to raise and appropriate the sum of \$200 to reimburse a Franklin County Tech school committee member for travel expense and \$600 for three Pioneer Valley Regional School Committee members for travel expense for FY 2020, or take any vote or votes in relation thereto.
